

Government Order

The undersigned is directed to convey the sanction of the Government of the people's Republic of Bangladesh in respect of Dr. S.M. - (a) The duration of meeting including the transit time will be treated as on duty;
- (b) He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- (c) Asia-Pacific Association of Agricultural Research Institutions (APAARI) will bear all the expenses of his participation in the meeting;
- (d) There will be no financial involvement of the Government of Bangladesh in this meeting;
- (e) He will leave Bangladesh for Thailand on 07 September, 2016 or on a nearer date and will leave Thailand for Bangladesh on 09 September, 2016 or on a nearer date;
- (f) He will not be allowed to stay abroad more than the approved period;
- (g) He will submit a report within 7 (seven) days after return from the Program;

3. This order is issued with approval of the competent authority.


