Government Order

 - d) There will be no financial involvement of the Government of Bangladesh in this regard;
 - e) He will leave from Bangladesh for China on 08 July, 2015 or on a nearer date and leave China for Bangladesh on 29 July, 2015 or on a nearer date;
 - f) He will not be allowed to stay abroad more than the approved period;
 - g) He will has to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.
2. This order is issued with the approval of the competent authority.


