Government Order

 - d) There will be no financial involvement of the Government of Bangladesh in this regard;
 - e) They will leave from Bangladesh for China on 10 August, 2015 or on a nearer date and leave China for Bangladesh on 01 September, 2015 or on a nearer date;
 - f) They will not be allowed to stay abroad more than the approved period;
 - g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.


