Subject: Government Approval to participate in the Experience Sharing Visit scheduled on 10-15 April 2016 in Philippines.


The undersigned is directed to convey the sanction of the Govt. of The People's Republic of Bangladesh in favor of the following officers to participate in the visit mentioned in the subject:
