

2. The terms and conditions are mentioned below:


- (a) The duration of training course including the transit time will be treated as on duty;

 - (c) All the expenses will be borne by the Safe Crop Production Project Through IPM Approach, DAE, Khamarbari, Dhaka.
 - (d) They will leave Bangladesh for Vietnam on 15 December, 2016 or on a nearer date and will leave Vietnam for Bangladesh on 24 December, 2016 or on a nearer date; and
 - (e) They will not be allowed to stay abroad more than the approved period;
 - (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
