

 - (d) They will leave from Bangladesh for India on 6 April, 2016 or on a nearer date and leave India for Bangladesh on 13 April, 2016 or on a nearer date;
 - (e) They will not be allowed to stay abroad more than the approved period;
 - (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) after return from the Program.
3. This order is issued with the approval of the competent authority.


