
Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Nazmun Nahar Karim, Principal Scientific Officer, Bangladesh Agricultural Research Council to participate in the Seminar on Management of Agriculture for Bangladesh to be held from 18 November to 08 December, 2015 in China under following terms and conditions;

2. Terms and conditions:

- a) The duration of seminar including the transit time will be treated as on duty;
- b) She will draw her pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- c) All the expenses will be borne by the Government of China;
- d) There will be no financial involvement of the Government of Bangladesh in this Senior;
- e) She will leave from Bangladesh for China on 17 November, 2015 or on a nearer date and leave China for Bangladesh on 09 December, 2015 or on a nearer date;
- f) She will not be allowed to stay abroad more than the approved period;
- g) She will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.

3. This order is issued with the approval of the competent authority.


