Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Md. Azim Uddin, Chief Seed Technologist, Seed Wing, Ministry of Agriculture to participate in the Expert Consultation on "Assessment of Common Crop Varieties, their Demand and Supply for SAARC Seed Bank" from 28-30 December, 2015 in Trivandrum, Kerala, India, under following terms and conditions;

- a. The duration of Program including the transit time will be treated as on duty;
- b. He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- c. All the expenses will be borne by SAARC Agriculture Centre;
- d. There will be no financial involvement of the Government of Bangladesh in this regards;
- e. He will leave Bangladesh for India on 27 December , 2015 or on a nearer date and will leave India for Bangladesh on 31 December, 2015 or on a nearer date;
- f. He will not be allowed to stay abroad more than the approved period;
- g. He will has to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.

2. This order is issued with the approval of the competent authority.


