2. Terms and conditions are mentioned below:


- (a) The duration of study tour including the transit time will be treated as on duty;

 - (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.
