Government Order



- e) They will leave from Bangladesh for China on **27 April, 2017** or on a nearer date and leave China for Bangladesh on **27 June, 2017** or on a nearer date;
- f) They will not be allowed to stay abroad more than the approved period;
- g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.


