

**Government Order**

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Md. Shamsheer Ali, Executive engineer, Barind Multipurpose Development Authority (BMDA), Rajshahi for visiting factory in China from 15-21 February, 2016 or a nearer date under following terms and conditions:-

- a. The duration of visit including the transit time will be treated as on duty;
  - b. He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;
  - c. All the expenses will be borne by United Trade Mart;
  - d. There will be no financial involvement of the Government of Bangladesh in this Program;
  - e. He will leave Bangladesh for China on 14 February, 2016 or on a nearer date and will leave China for Bangladesh on 22 February, 2016 or on a nearer date;
  - f. He will not be allowed to stay abroad more than the approved period;
  - g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) after return from the Program.
2. This order is issued with the approval of the competent authority.


