Government Order

 - b. He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;
 - c. Asia Pacific Seed Association (APSA) will bear all the expenses of his participation in the Program;
 - d. There will be no financial involvement of the Government of Bangladesh in this Program;
 - e. He will leave Bangladesh for Thailand on 11 August, 2015 or on a nearer date and will leave Thailand for Bangladesh on 14 August, 2015 or on a nearer date;
 - f. He will not be allowed to stay abroad more than the approved period;
 - g. He will has to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.
