

Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Mr. Billal Hossen, Agriculture Extension Officer (LR), Department of Agricultural Extension, Khamarbari, Farmgate, Dhaka to participate in the training course on " Plant Variety Protection and Quality Control System of Seeds to Facilitate Distribution of High Quality Seeds (J1604052)" to be held in Japan from June 12, 2016 to September 22, 2016 and Vietnam from September 23, 2016 to September 29, 2016 under following terms and conditions;

- a. The duration of training including the transit time will be treated as on duty;
- b. He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- c. Japan International Co-operation Agency (JICA) will bear all the expenses of his participation in the training;
- d. There will be no financial involvement of the Government of Bangladesh in this training;
- e. He will leave Bangladesh for Japan on 11 June, 2016 or on a nearer date and will leave Vietnam for Bangladesh on 30 September, 2016 or on a nearer date;
- f. He will not be allowed to stay abroad more than the approved period;
- g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.


