Government Order



- (d) There will be no financial involvement of the Government of Bangladesh in this regard;
- (e) They will leave from Bangladesh for Philippines on 21 June, 2016 or on a nearer date and leave Philippines for Bangladesh on 25 June, 2016 or on a nearer date;
- (f) They will not be allowed to stay abroad more than the approved period;
- (g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) after return from the Program.


