2. Terms and conditions:

- a) The duration of seminar including the transit time will be treated as on duty;
- b) They will draw their pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- c) All the expenses will be borne by the Government of China.
- d) There will be no financial involvement of the Government of Bangladesh in this regard;
- e) They will leave Bangladesh for China on 11 September, 2015 or on a nearer date and leave China for Bangladesh on 19 September, 2015 or on a nearer date;
- f) They will not be allowed to stay abroad more than the approved period;
- g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.
