 - (f) He will submit a report to the ministry within 07 (seven) days after his return from abroad.
 - (g) He will be treated as Upazila Agriculture Officer (LR) during his study period.
 - (h) He will join as Upazila Agriculture Officer (LR) in Department of Agricultural Extension after completion of the PhD Course.


