

Government Order

  - e. He will leave Bangladesh for India on 24 January, 2016 or on a nearer date and will leave India for Bangladesh on 19 March, 2016 or on a nearer date;
  - f. He will not be allowed to stay abroad more than the approved period;
  - g. He will has to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
2. This order is issued with the approval of the competent authority.


