
Government Order

2. Terms and conditions:


- a) The duration of seminar including the transit time will be treated as on duty;

 - d) There will be no financial involvement of the Government of Bangladesh in this Seminar;
 - e) They will leave from Bangladesh for China on 20 July, 2016 or on a nearer date and leave China for Bangladesh on 11 August, 2016 or on a nearer date;
 - f) They will not be allowed to stay abroad more than the approved period;
 - g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
