Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Mr. Anarul Kabir, Deputy Chief (Planning), Department of Agricultural Marketing, Khamarbari, Dhaka to participate in the training course on "Local Industry Development in Agricultural Regions by Strengthening Capacity of Management and Marketing (B)" in Japan from 11 January to 13 February, 2016, under following terms and conditions;

 - b. He will draw his pay and allowances in local currency, no part of it shall be drawn in foreign currency;

 - d. There will be no financial involvement of the Government of Bangladesh in this training;
 - e. He will leave Bangladesh for Japan on 10 January, 2016 or on a nearer date and will leave Japan for Bangladesh on 14 February, 2016 or on a nearer date;
 - f. He will not be allowed to stay abroad more than the approved period;
 - g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.
2. This order is issued with the approval of the competent authority.


