 - f. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.
 - g. He will join as Senior Assistant Director in Bangladesh Agricultural Development Corporation after completion of the PhD Course.
2. This order is issued with the approval of the competent authority.


