

Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Md. Ariful Islam, Assistant Chief and Md. Saimur Rashid Khan, Assistant Chief, Ministry of Agriculture to participate in the training course on "Planning of Agricultural Policy" (J15-04404 from 16 August to 19 September, 2015 in Japan, under following terms and conditions;

- a. The duration of training including the transit time will be treated as on duty;
 - b. They will draw their pay and allowances in local currency, no part of it shall be drawn in foreign currency;
 - c. Japan International Co-operation Agency (JICA) will bear all the expenses of their participation in the training;
 - d. There will be no financial involvement of the Government of Bangladesh in this training;
 - e. They will leave Bangladesh for Japan on 15 August, 2015 or on a nearer date and will leave Japan for Bangladesh on 20 September, 2015 or on a nearer date;
 - f. They will not be allowed to stay abroad more than the approved period;
 - g. They will have to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.
2. This order is issued with the approval of the competent authority.


