Government Order

- (d) There will be no financial involvement of the Government of Bangladesh in this Program;
- (e) They will not be allowed to stay abroad more than the approved period;
- (f) They will leave Bangladesh for Italy and Sweden on 05 March, 2017 or on a nearer date and will leave Italy/Sweden for Bangladesh on 11 March, 2017 or on a nearer date; and
- (g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the visit.
