

Government Order

 - d. There will be no financial involvement of the Government of Bangladesh in this program;
 - e. He will leave from Bangladesh for Thailand on 30 October, 2016 or on a nearer date and leave Thailand for Bangladesh on 21 November, 2016 or on a nearer date;
 - f. He will not be allowed to stay abroad more than the approved period;
 - g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
