Government Order

- (d) There will be no financial involvement of the Government of Bangladesh in this course;

- (f) He will leave Bangladesh for U.A.E on 19 March, 2017 or on a nearer date and will leave U.A.E for Bangladesh on 22 March, 2017 or on a nearer date; and
- (g) He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the visit.
