Government Order

- d. They will leave Bangladesh for China on 17 August, 2016 or on a nearer date and will leave China for Bangladesh on 25 August, 2016 or on a nearer date;
- e. They will not be allowed to stay abroad more than the approved period;
- f. They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
