- (e) They will leave Bangladesh for Germany on 17 June, 2016 or on nearer date and will leave Germany for Bangladesh on 25 June, 2015; or nearer date; and
- (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.


