**Government Order**

  - (d) They will leave from Bangladesh for China on 16 April, 2016 or on a nearer date and leave China for Bangladesh on 27 April, 2016 or on a nearer date;
  - (e) They will not be allowed to stay abroad more than the approved period;
  - (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) after return from the Program.
3. The G.O No- 12.00.0000.021.25.005.15- 151, dated: 06-04-2016 from the Ministry of Agriculture is hereby cancelled.
  4. This order is issued with the approval of the competent authority.


