

Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Md. Azim Uddin, Chief Seed Technologist, Seed Wing, Ministry of Agriculture to participate in the general assembly on " International Tropical Fruits Symposium & International Tropical Fruits Network (TFNet)" from 03-06 August, 2015 in Colombo, SriLanka, under following terms and conditions;

- g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days after arrival in the country.

2. This order is issued with the approval of the competent authority.


