- (d) They will leave from Bangladesh for Thailand on 11 June, 2016 or on a nearer date and leave Thailand for Bangladesh on 21 June, 2016 or on a nearer date;
- (e) They will not be allowed to stay abroad more than the approved period;
- (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.


