  - d. They will leave Bangladesh for India on 16 July, 2016 or on a nearer date and will leave India for Bangladesh on 24 July, 2016 or on a nearer date;
  - e. They will not be allowed to stay abroad more than the approved period;
  - f. They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
