
I am directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of the following officers to participate in the study tour mentioned in the subject.

- (f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribe format of Mopa) of after return from the Program.


