02. Terms and conditions:

 - c. Japan International Co-operation Agency (JICA) will bear all the expenses of his participation in the training;
 - d. There will be no financial involvement of the Government of Bangladesh in this training;
 - e. He will leave Bangladesh for Japan on 08 January, 2017 or on a nearer date and will leave Japan for Bangladesh on 10 February, 2017 or on a nearer date;
 - f. He will not be allowed to stay abroad more than the approved period;
 - g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
