
Government Order

- e) They will leave from Bangladesh for Korea on 29 May, 2016 or on a nearer date and leave Korea for Bangladesh on 04 June, 2016 or on a nearer date;
- f) He will not be allowed to stay abroad more than the approved period;
- g) He will has to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.

3. This order is issued with the approval of the competent authority.


