2. The terms and conditions for the said Program are mentioned below:

- a. The duration of the Program including the transit time will be treated as on duty;
 - b. They will draw their pay and allowances in local currency, no part of it shall be drawn in foreign currency;
 - c. All the expenses will be borne by the APAARI (Asia-Pacific Association of Agricultural Research Institutions);
 - d. There will be no financial involvement of the Government of Bangladesh in this program;
 - e. They will leave from Bangladesh for Thailand on 07 December, 2015 or on a nearer date and leave Thailand for Bangladesh on 10 December, 2015 or on a nearer date and Dr. Md. Abdul Awal, Chief Scientific Officer leave Thailand for Bangladesh on 11 December, 2015 or on a nearer date;
 - f. They will not be allowed to stay abroad more than the approved period;
 - g. They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.


