
I am directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of the following officers to participate in the training Course/Study tour mentioned in the subject :

- e) They will not be allowed to stay abroad more than the approved period;
- f) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Exposure Visit;
