Government Order

2. Terms and conditions:

- d. There will be no financial involvement of the Government of Bangladesh in this course;
- e. They will leave Bangladesh for India on 30 November, 2016 or on a nearer date and will leave India for Bangladesh on 01 February, 2017 or on a nearer date;
- f. They will not be allowed to stay abroad more than the approved period;
- g. They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the Program.
