Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in respect of Mr. Md. Lutfor Rahman, Deputy Chief Engineer, Bangladesh Agricultural Development Corporation (BADC), Dhaka to participate in the Climate Services Users Forum for Agriculture (CSUF-Ag1) to be held in Chennai, Tamil Nadu, India from 15-16 October, 2015 under following terms and conditions;

- a. The duration of programme including the transit time will be treated as on duty;
 - b. He will draw her pay and allowances in local currency, no part of it shall be drawn in foreign currency;
 - c. Regional Integrated Multi-Hazard Early Warning System (RIMES) will bear all the expenses of his participation in the programme;
 - d. There will be no financial involvement of the Government of Bangladesh in this programme;
 - e. He will leave Bangladesh for India on 14 October, 2015 or on a nearer date and will leave India for Bangladesh on 17 October, 2015 or on a nearer date;
 - f. He will not be allowed to stay abroad more than the approved period;
 - g. He will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.
