**Government Order**



- d) There will be no financial involvement of the Government of Bangladesh in this training;
- e) They will leave from Bangladesh for Thailand on 21 May, 2017 or on a nearer date and leave Thailand for Bangladesh on 03 June, 2017 or on a nearer date;
- f) They will not be allowed to stay abroad more than the approved period;
- g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of Mopa) of after return from the Program.
